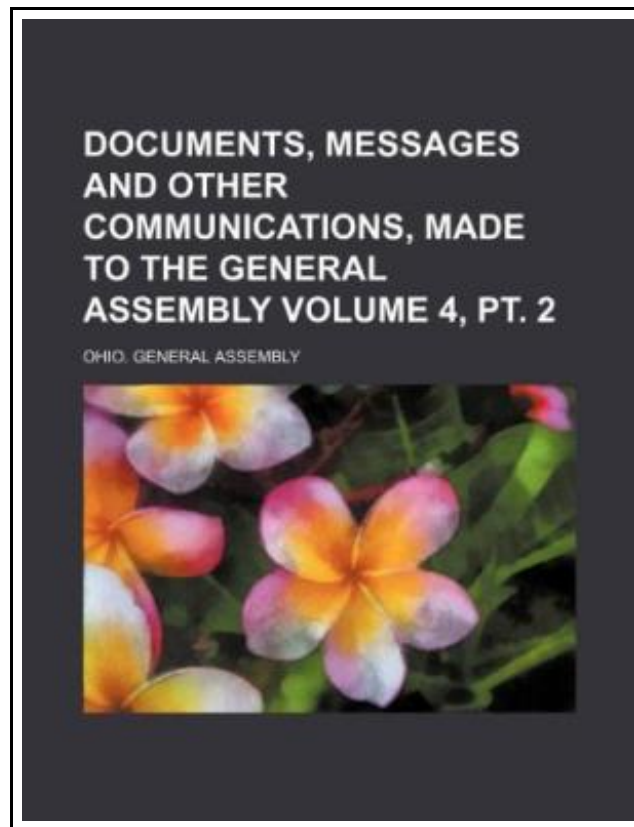

The number of agents and sub-agents, managers or directors, with their names, in any way, now, or within the last year, engaged upon salary or per diem wages, in the employment of the State of Ohio, on the National Road. 2. The salary or per diem rates of each severally paid, with an explicit statement of services rendered the State, as to the kind, c, aa well as in relation to the kind of contracts entered into between the State and said individuals in its employ, on said road. 3. Whether any perquisites are attached to any or either of ihe offices or agents connected with the management of said road in this Slate; the Board submit the following REPORT: The road is placed under the special charge of Thomas M. Drake, as Sp erintendent, with a salary allowance of \$1,300 per annum. Tba other agents are...
