Third, USTR is the lead agency, working closely with other agencies, in addressing IPR issues multilaterally through the WTO. The initiation of dispute settlement proceedings is the most forceful expression in the WTO of dissatisfaction with a countrys IPR protection and can be an effective way to achieve reform. In nearly all cases that USTR has initiated, U. S. concerns were addressed via changes in laws and regulations by the other party. We also regularly review countries IPR laws and practices through the WTO Trade Policy Review mechanism and in the TRIPs Council. Fourth, USTR administers the Generalized System of Preferences program and other similar programs which allow us to withhold tariff preferences if a country fails to adequately protect IPR. The carrot of preserving tariff preferences is an effective incentive for countries to protect intellectual property rights. Finally, USTR, the State Department, the Department of Commerce and others have used diplomatic pressure to encourage IPR reform around the world. For...
